





Image 2: Registration Form - 1



**Getting Started:** As a broker, you can access three options on the landing page of the 24/7 Truckin web portal:

- Login: If you already have an account, click on login and access your account.
- Register: If you do not have an account, sign up and register your account.
- Quick Access: This feature allows you to experience the functionalities of the web portal using a dummy account.

Register/Sign-Up on the Web Portal: A broker must register their company on the 24/7 Truckin web application. The experience begins with a thorough registration process.

### **Steps to Register:**

#### 1. Open the 24/7 Truckin Web Portal:

Go to the "24/7 Truckin website". Then "Click" on the "Register" button.

## 2. Registration Screen:

You will be "redirected" to the "registration screen". The registration process consists of three steps.

**Step 1: Legal Information** 

The broker needs the following valid documents/certificates from the "Federal Motor Carrier Safety Administration" (FMCSA) to "legally register" and "transfer goods":

- MC Number
- DOT Number





**Note:** Companies operating in interstate commerce are identified by their "US DOT numbers". Companies transporting regulated goods for hire in interstate commerce are identified by their "MC numbers". Items modified from their original state are classified as "controlled commodities" and need an "MC number".



**For example,** if you are shipping items within your "state", you might only need a "USDOT number". However, to comply with "federal laws" for interstate operating authorization, you must obtain an MC identification number if transporting goods across state lines.

# Fill in the legal information accurately:


- Enter company details, including your "company's legal name", "US DOT number", "MC number", "address", "phone number", "zip code", "city", and "state".
- "Click" on "Next".

# **Step 2: Personal Information**

- "Enter" your "personal information".
- "Click" on "Send OTP".
- "Enter" the "One-Time Password" received on your phone.
- "Click" on "Next".

#### **Step 3: Account Creation**

- You will be redirected to a screen indicating that your account has been created.
- "Log in" using the given "phone number" to access the exclusive features of the web portal.
- "Click" on "Login" to proceed
